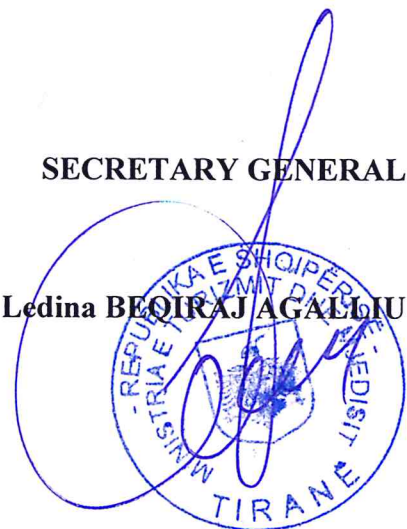
You will find attached to the present letter the completed designation form pursuant to his nomination.
